Zoning Administrator's Report: On file.

Fire Board Report: Stockwell reported the fire Department received the grant from Par Plan and will install security cameras on the outside of the building.

Supervisor's Report: The Par Plan grant was not approved because we asked for cameras in two different property's. Rodarmer will resubmit for cameras just at the cemetery and next year apply for cameras at the Township Hall..

Unfinished Business

Roads: Motion by Stockwell, second by Ungrey to pay for a replacement sign on Apaches to include "pvt drive". All ayes, motion carried.

Backdoor stair case: two bids were received to replace the deck and stairs. Motion by Noggle, second by Rodarmer to accept the proposal from Stockwell Construction for accost of \$1,300.00 to replace and remove the old stairs and steps and replace with a 4x4 deck and stairs. 4 ayes, 1 abstain (Amy Stockwell), no apposed, motion carried.

New Business

Land split for Hummel: Motion by Rodarmer, second by Noggle to deny the land split because the split is creating a parcel under 5 acres, All ayes, motion carried. Options to create a legal split were given to the Zoning Administrator.

Motion by Rodarmer, second by Stockwell to approve the Clerk and Deputy Clerk attending a 2 day conference in September. All ayes, motion carried.

Motion by Ungrey, second by Stockwell to pay the bills with additions. All ayes, motion carried.

Public Comment: Craig Osterhouse wants to build a pole barn that was approved by Barager, past Zoning Administrator, but now the new Administrator is saying it can not be built because it will not meet setbacks. Discussion and action postponed until next month, Noggle will do some research to see what past information can be found.

With no objections, the Supervisor declared the meeting adjourned.
