

**DOCK AND BOAT PERMIT FOR THE PARK IN THE
REED'S DIAMOND LAKE PLAT**

This permit application is governed by the Lincoln Township ordinance commonly known as the "Lincoln Township Waterfront Park Ordinance" (hereinafter, the "Ordinance") and applies to the park (the "Park") located within the Reed's Diamond Lake Plat between the waters of Diamond Lake and Mohawk Trail.

To keep in full force and effect at all times liability insurance in an amount of at least \$500,000 covering the dock, any use thereof, and any boats which I/we may moor or utilize at the dock or the Park. Should any such insurance be canceled or not be renewed, I/we will file a written notice of the same with the Township Clerk immediately.

2. My family and I/we will abide by all conditions, requirements, and regulations of the Ordinance (which governs the use of the Park), as well as any terms or conditions of the dock permit (or the Township-approved site map/plan) and any other applicable Lincoln Township ordinance.
3. I/We understand that any violation of the ordinance governing the Park, this permit, or any Township ordinance will allow the Township to cancel this permit (and require the removal of my/our dock and boats from the Park).

I/We agree to reimburse, indemnify and hold harmless Lincoln Township (as well as its officials, officers, employees, contractors and agents) for, from and against any and all damages, liabilities, lawsuits, causes of action, attorney fees, costs and other matters relating to, arising out of or regarding any dock permit issued to me/us, my/our use of the Park and my/our use of the dock and boat(s) thereon.
