

November 21, 2024, Lincoln Township Regular Board meeting, called to order by Supervisor Rodarmer at 7:00 pm.

Rodarmer led all present in the Pledge of Allegiance.

Ungrey motioned to approve the minutes from the October 17, with one correction supported by Rodarmer, all ayes, minutes approve.

Stockwell motioned to approve the agenda, supported by Bulson. All Ayes, agenda approved.

Public Comment: Supervisor Rodarmer asked if there were any Public Comments, with the directive that they pertain to agenda and be directed to her.

Reports:

Zoning Administrator: Milan gave us his report on Permits issued for October. Supervisor Rodarmer stated that there have been some issues with Land Split / Combinations. The assessor is supposed to approve and then take them to Equalization, but because that is not happening in a timely fashion Milan will be turning those in from now on.

Fire Board: D. Brown, Lincoln Township Fire Board rep, 3 runs in Lincoln Twp in the month of October. Budget meeting at the Fire Dept Dec 30 @ 6:00 pm.

Treasurer's Report: Rodarmer motioned to accept the Treasurers report, support by Ungrey, all ayes, report accepted

Supervisors Report: We missed the Newsletter for December. There is a neighbor dispute on Lincoln, Authorities have been called. Stockwell thinks we should all have a call log to keep track of incoming calls. Stockwell will order these for board members, Assessor Beach and Zoning Administrator Nerad. Tentative Draft of the Master Plan is on the website. Clarification -- 27 Days and under are considered Short Term Rentals. Getting quotes for additional signage to be added to the Veterans Memorial Roll Call Board at the Cemetery. Will be checking into capping old, non-usable outhouse at Diamond Lake. BOR meeting Dec 10 at the Library Community room.

Since we don't meet in December, Rodarmer motioned to have the clerk pay the December Bills when due, Support by Stockwell, all ayes, motion passed

Public Comments: DLA chairman Deck Andrejczak has said 3098 N Arrowhead Pass is utilizing the roadway as part of their yard. He is requesting that the property owner follows the rules.

Board Comment: Rodarmer wants the approved minutes sent to the webmaster following each meeting, the clerk will be sending those each month.

Clerk Bulson motioned to suspend garbage service at the Cemetery from January 1, 2025 to April 1, 2025. Rodarmer supported, all ayes, motion passed.
